First Industry Roundtable:

Backing the Critical Raw Materials Act and reinforcing the EU strategic autonomy

The Critical Raw Materials Act (CRMA), published in 2024, addresses the EU's challenges in advancing energy transition and achieving climate-neutrality by 2050. It establishes a target of 10% domestic extraction of critical raw materials by 2030, expedites permitting for mining projects, enhances supply disruption monitoring, and upholds rigorous social and environmental standards.

However, CRMA implementation faces institutional, techno-economic, and social-environmental barriers. Public acceptance emerges as particularly crucial, affecting operations, policy implementation, and financing. Opposition to mineral and industrial projects often stems from a perceived disconnect between EU-level priorities and local interests, amplified by Euroscepticism, institutional distrust, and inequality concerns. Traditional approaches based solely on technical assessments and expert consensus have proven inadequate.

The current situation demands a two-pronged strategy to: (i) derisk mineral value chains; and (ii) support Member States in fostering public acceptance. This roundtable examines approaches addressing both challenges, demonstrating how technological innovations can derisk mining operations by making mineral extraction virtually "invisible", while novel social contracts and business models, such as combination of CRM extraction with energy production, can build public support for extractive projects—creating an optimal balance between securing critical raw materials for the energy transition and safeguarding Europe's natural capital.
